## **GROUND SPACE AGREEMENT**

This Agreement is between the undersigned (hereinafter called "the Exhibitor") and the Clunes and District Agricultural Society Inc. (hereinafter called the Society, and shall mean the office bearers and Committee of the Society).

Hereby it is agreed as follows :-

1. The Society has agreed to lease to the Exhibitor a site at the Clunes and District Show on **15th** of **November 2008** as detailed in the schedule.
2. Full payment of site fees and entry passes must accompany the signed Agreement form.
3. This Agreement must be completed by the Exhibitor and returned to the Society by 1st of November.
4. The Society reserves the right to cancel this Agreement and to retain any money paid here under, if in the opinion of the Society the Exhibitor has breached any of the conditions of this Agreement, or if the Exhibitor fails to occupy the allotted site by 12 noon on Show Day.
5. The Exhibitor shall not conduct within the Showgrounds, any competition, game or sale by auction not approved in writing by the Society.
6. Please enclose with your deposit an extra \$ 18.00 for **VAS Ltd Public Liability Insurance Fee** (This charge is beyond the Society's control), unless proof of current Public Liability Insurance Policy is included with application.
7. The Society shall not be held liable for loss of, or damage to the Exhibitor's property whilst on the showgrounds.
8. The Society reserves the right to forbid practical demonstrations by the Exhibitor if the Society considers the demonstration is inherently dangerous or if there is likelihood of damage to person or property due to prevailing weather conditions.
9. **All Exhibitors and stallholders** shall pay full admission to enter the showgrounds or show a **Stallholders Pass** to enter the showgrounds. Such Passes are available at a discounted rate of **\$8.00 per adult**. Full payment of Entry Pass is required with site fee.

10. Trestles etc. cannot be provided by the Society.
11. If confirmation of booking is required please enclose a stamped self-addressed envelope.
12. All exhibits to be on the Showgrounds by 10 am on Show day.
13. Exhibitors may set up from 4 p.m. on the day prior to the show.
